Bullish Flag Break-out Ahead?



Technical Highlights

The stock has been in a consolidation phase but is now showing promising signs of a bullish breakout. The recent price action has formed a bullish flag pattern, which typically indicates a continuation of the prior uptrend. Yesterday, the stock broke out of this pattern, moving decisively above its three key EMAs (20, 50, and 200), signalling strong buying interest. The breakout was accompanied by a significant increase in volume, further confirming the bullish sentiment.

Momentum indicators are also turning positive. The MACD recently formed a golden cross, reinforcing the upward momentum, while the RSI stands at 55.2, indicating that the stock is gaining strength as it continues to rise.

Given the bullish flag breakout, a slight pullback could offer an attractive entry point. If the stock breaks above the critical RM0.415 resistance level (52-week high), it could target the next new resistance at RM0.465. However, if the price dips below RM0.340, it may signal the start of a correction phase.

Revisiting its 52-week High?



Technical Highlights

The stock has been exhibiting a bullish trend over the past period. Currently, a triangle pattern is formed, which typically indicates a continuation of the prior uptrend. The sustained high-volume buying activity paired with this pattern shows that there is an accumulation from market participants. Furthermore, the stock has been consistently trading above its 200-day EMA, providing strong support. It is also comfortably positioned between the 20 and 50-day EMAs.

Momentum indicators are also turning positive. The MACD is about to form a golden cross. Although the RSI is in the neutral zone, the arrow has recently started pointing up, signalling upward strength at this level.

Given strong momentum and trading volume, a decisive break above the RM1.04 will confirm the breakout of the triangle pattern. This breakout has the potential to unlock significant upside, with the stock aiming for testing resistance at RM1.09 first and thereafter at RM1.19. On the flipside, a dip below RM0.970 could signify the start of a correction phase.

Glossary of commonly used technical terms

Exponential Moving Average (EMA)	An indicator frequently used in technical analysis showing the average value of a security's price over a set period with greater weightage placed on the most recent data points.
Moving Average Convergence Divergence (MACD)	A trend-following momentum indicator that shows the relationship between two moving averages of prices. The MACD is calculated by subtracting the 26-day exponential moving average (EMA) from the 12-day EMA. A 9-day EMA of the MACD, called the "signal line", is then plotted on top of the MACD, functioning as a trigger for buy and sell signals.
Stochastic	A technical momentum indicator that compares a security's closing price to its price range over a given time period. The indicator's sensitivity to market movements can be reduced by adjusting the time period or by taking a moving average of the result.
Average True Range (ATR)	A measure of volatility whereby the indicator is the greatest of the following: <ul style="list-style-type: none">- current high less the current low;- the absolute value of the current high less the previous close;- the absolute value of the current low less the previous close;
Bollinger Band	A band plotted 2 standard deviations away from a simple moving average.
On-Balance Volume (OBV)	A method used in technical analysis to detect momentum, the calculation of which relates volume to price change. OBV provides a running total of volume and shows whether this volume is flowing in or out of a given security.
Support	The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.
Resistance	The price at which a stock or market can trade, but not exceed, for a certain period of time. Often referred to as "resistance level".
Reversal	A change in the direction of a price trend. On a price chart, reversals undergo a recognisable change in the price structure. An uptrend, which is a series of higher highs and higher lows, reverses into a downtrend by changing to a series of lower highs and lower lows. A downtrend, which is a series of lower highs and lower lows, reverses into an uptrend by changing to a series of higher highs and higher lows.
Divergence	When the price of an asset and an indicator, index or other related asset move in opposite directions.
Overbought	In technical analysis, this term describes a situation in which the price of a security has risen to such a degree – usually on high volume – that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.
Oversold	A situation in technical analysis where the price of an asset has fallen to such a degree – usually on high volume – that the oscillator has reached a lower bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors
