Momentum Indicators Turn Bullish



Technical Highlights

Last closed at RM0.600, the stock rebounds from its first support level at RM0.580. The price had formed a compression channel following its rally from its consolidation zone post-downtrend breakout back in December 2025. The price had tested both upper and lower bands of the compression channel twice, indicating the structure to remain intact. Moving forward, we anticipate the price to move towards testing the upper band, before staging a breakout if momentum persists.

Momentum indicators are bullish, as the RSI rises towards the overbought zone, while the lagging MACD line had crossed above the signal line, indicating momentum build-up. The stock had maintained well above its 200-day EMA, indicating overall bullish trend in the long term. Meanwhile, a bullish confirmation will be validated once the price opens above its 20- and 50-day EMAs.

On the upside, the immediate target is RM0.615, with further strength potentially extending towards RM0.650 should momentum build. Conversely, a breach below its support levels would invalidate the bullish outlook and expose the stock to further downside.

Support Rebound as Long-Term Trend Likely to Persist



Technical Highlights

The stock last closed at RM0.905, after staging a rebound from its second support at RM0.890 in the previous sessions. Previously, the stock had rallied to its 52-week high since breaking out of its two-year trendline as the price cools down towards its last close. As the trend reversal holds, we view the bullish trend to continue strongly as it has broken out of a significant resistance.

Momentum indicators are mixed, as the RSI was flattish around the 50-level, while the MACD line is yet to cross above the signal line. The price had been trading well above its 200-day EMA, indicating a bullish outlook in the long term. Meanwhile, the stock had rebounded from its 50-day EMA, reinforcing the bullish trend in the medium term, while a cross above its 20-day EMA will provide a bullish confirmation in the near term.

On the upside, the immediate target is RM0.920, with further strength potentially extending towards RM0.935 should momentum build. Conversely, a breach below its support levels would invalidate the bullish outlook and expose the stock to further downside.

Glossary of commonly used technical terms

Exponential Moving Average (EMA)	An indicator frequently used in technical analysis showing the average value of a security's price over a set period with greater weightage placed on the most recent data points.
Moving Average Convergence Divergence (MACD)	A trend-following momentum indicator that shows the relationship between two moving averages of prices. The MACD is calculated by subtracting the 26-day exponential moving average (EMA) from the 12-day EMA. A 9-day EMA of the MACD, called the "signal line", is then plotted on top of the MACD, functioning as a trigger for buy and sell signals.
Stochastic	A technical momentum indicator that compares a security's closing price to its price range over a given time period. The indicator's sensitivity to market movements can be reduced by adjusting the time period or by taking a moving average of the result.
Average True Range (ATR)	A measure of volatility whereby the indicator is the greatest of the following: <ul style="list-style-type: none">- current high less the current low;- the absolute value of the current high less the previous close;- the absolute value of the current low less the previous close;
Bollinger Band	A band plotted 2 standard deviations away from a simple moving average.
On-Balance Volume (OBV)	A method used in technical analysis to detect momentum, the calculation of which relates volume to price change. OBV provides a running total of volume and shows whether this volume is flowing in or out of a given security.
Support	The price level which, historically, a stock has had difficulty falling below. It is thought of as the level at which a lot of buyers tend to enter the stock.
Resistance	The price at which a stock or market can trade, but not exceed, for a certain period of time. Often referred to as "resistance level".
Reversal	A change in the direction of a price trend. On a price chart, reversals undergo a recognizable change in the price structure. An uptrend, which is a series of higher highs and higher lows, reverses into a downtrend by changing to a series of lower highs and lower lows. A downtrend, which is a series of lower highs and lower lows, reverses into an uptrend by changing to a series of higher highs and higher lows.
Divergence	When the price of an asset and an indicator, index or other related asset move in opposite directions.
Overbought	In technical analysis, this term describes a situation in which the price of a security has risen to such a degree – usually on high volume – that an oscillator has reached its upper bound. This is generally interpreted as a sign that the price of the asset is becoming overvalued and may experience a pullback.
Oversold	A situation in technical analysis where the price of an asset has fallen to such a degree – usually on high volume – that the oscillator has reached a lower bound. This is generally interpreted as a sign that the price of the asset is becoming undervalued and may represent a buying opportunity for investors
